1. **Legal advice.** I understand and accept that if I am uncomfortable with, unwilling to accept or do not understand any of the following terms, I should either choose not to participate or seek independent legal advice before committing any funds to the purchase of \$HAZE tokens.
2. **Due diligence.** I understand and accept that I should conduct thorough research and due diligence before purchasing any cryptocurrency and before committing funds to purchase of the \$HAZE token, including by evaluating the project's team, technology, and community, as well as understanding the risks involved.
3. **Sufficient knowledge.** I understand and accept that I should not commit any funds to the purchase of \$HAZE unless I am satisfied that I have all necessary and relevant experience, knowledge and understanding of the \$HAZE token, the Hazeman project and cryptocurrencies generally.
4. **No review or approval.** I understand and accept that the \$HAZE token, the Hazeman project and these terms have not been reviewed by, passed on, submitted to or approved by any international, national, federal or state agency, authority, governmental department or self-regulatory organisation.
5. **No investment.** I understand and accept that these terms do not constitute a prospectus or offering document and do not and are not intended to constitute an offer to sell, nor the solicitation of any offer to buy, an investment, a security, a financial instrument, a commodity, e-money or an option on or any other right to acquire any such investment, security, financial instrument, e-money or commodity.
6. **Balance of risk.** I understand and accept that only I bear the economic and other risks of my purchase of \$HAZE tokens.
7. **Lack of intrinsic value/utility.** I understand and accept that memecoins/lifestyle tokens such as \$HAZE may not have any intrinsic value or utility; unlike some cryptocurrencies that are tied to projects or platforms, memecoins and lifestyle tokens often lack underlying technology or use cases, making their value solely dependent on market sentiment.
8. **Tokens bought as is.** I understand and accept that any purchase of the \$HAZE token is on an "as is" basis and I have not relied on any guarantees or assurances that the \$HAZE token and Hazeman project will be fully developed, successful, gain a substantial or speculative commercial value or achieve merchantability or profitability.
9. **Conditional on launch.** I understand and accept that I will only receive \$HAZE tokens if the actual launch of the token takes place, that delays may occur and that the launch date and roadmap is subject to change at the team's discretion.
10. **Own decision.** I understand and accept that it is my sole decision whether or not to buy \$HAZE tokens, I have full capacity to make this decision and I have not been pressured by any external influence to make this decision.
11. **No investment advice.** I understand and accept that any information about \$HAZE tokens that I have received, including information contained in documents, a whitepaper, tokenomics descriptions, communications or websites has been issued for informational purposes only, is not intended to constitute investment advice or form the basis of any decision to purchase \$HAZE tokens, is not binding and is subject to amendment and/or change at any time.
12. **No guaranteed returns.** I understand and accept that I am not relying on any assurances of guaranteed financial returns or returns of value and no such returns may occur.
13. **Risk of complete loss of funds.** I understand and accept that purchasing cryptocurrencies such as \$HAZE carries a high risk of losing the entire value of the funds I have committed through my

purchase and that the unpredictable nature of the market and the lack of regulation can make it difficult to recover losses.

14. **Lack of protections.** I understand and accept that I may not have access to any regulatory or other investment protections, including compensation funds, ombudsmen or similar.
15. **Only funds you can afford to lose.** I understand and accept that I should only commit funds to purchase of the \$HAZE token that I can afford to lose and that \$HAZE is a high-risk token and should not be considered a safe haven for funds.
16. **Potential for change.** I understand and accept that the tokenomics and/or utility and/or functionality and/or narrative of the \$HAZE token may be amended at any time by the Hazeman team, including for operational and/or regulatory reasons.
17. **Need for community support.** I understand and accept that the success of \$HAZE is dependent on community support and social media hype, which is beyond the control of the Hazeman team and can be unpredictable and unsustainable, leading to rapid price changes and potential market manipulation.
18. **Volatility risk.** I understand and accept that cryptocurrencies such as \$HAZE are experimental, highly volatile and speculative and no guarantees have been made as to the price or other value of the \$HAZE token; prices can fluctuate dramatically based on social media trends and online communities, leading to significant gains or losses in a short period.
19. **Community risk.** I understand and accept that the sale of \$HAZE tokens by other community members may contribute to a reduced value of my own holdings.
20. **Regulatory risk.** I understand and accept that \$HAZE and the Hazeman project may be subject to regulatory restrictions or bans in certain jurisdictions, which could have a negative price impact.
21. **Security risk.** I understand and accept that the \$HAZE token may be subject to security risks, such as sniping, hacking and fraud by malicious third parties or bugs and vulnerabilities, and that these risks carry the potential for my tokens to be stolen or lost, or for their value to fall rapidly, due to technical vulnerabilities or malicious actors.
22. **Liquidity risk.** I understand and accept that \$HAZE may not be easily transferable, liquid or exchangeable at any time and that limited liquidity and exchange support can make it difficult to buy or sell such tokens when desired.
23. **Early stage venture risk.** I understand and accept that the Hazeman project is an early stage venture and that there are risks associated with participating in early stage businesses, including but not limited to difficulties caused for the business by lack of adequate capital, difficulties hiring or retaining key personnel, a competitive market, the uncertain impact of marketing efforts and operational risks.
24. **Tax risk.** I understand and accept that there may be tax implications involved in buying and selling \$HAZE, that I am solely responsible for paying any taxes due based on my purchase and/or sale of \$HAZE tokens, that tax laws and regulations vary by jurisdiction and that I should consult with a qualified professional to understand my obligations.
25. **Limited rights.** I understand and accept that purchase and ownership of the \$HAZE tokens does not entitle me to any voting rights, intellectual property rights or information rights.
26. **No refunds.** I understand and accept that I have no right at any time and in any circumstances to demand a refund of any funds I have committed to the purchase of \$HAZE tokens.

27. **Prohibitions on participation.** I understand and accept that I cannot and should not purchase \$HAZE tokens if I am prohibited by applicable laws, decrees, regulation, treaties or administrative acts from doing so or if I am subject to any sanctions imposed by any government or non-governmental organisation.
28. **No illicit funds.** I understand and accept that I cannot use illicit funds or funds derived from or related to any unlawful activities to purchase \$HAZE tokens.
29. **Responsibility to safeguard tokens.** I understand and accept that it is my sole responsibility to secure and preserve my sole access to and the safekeeping of any \$HAZE tokens in my possession, including by safely storing my private keys and/or passwords, and I am solely responsible for any losses of tokens caused by loss of access.
